eduCourse Data Model

1. Introduction

One of the goals of the MACE-courseID working group is to produce schema and recommended practices for identifying objects related to courses. This document presents the eduCourse data model, an abstract UML model that provides a frame of reference for the object lasses under consideration by the working group and identifies their primary interrelationships and some of their leading attributes. Two schematic derivatives of the abstract model are also presented.

The eduCourse data model does not fully characterize all attributes of the object classes being identified. However, it should suffice to clarify the types of instances to which identifiers must be attached, and about which the working group will recommend good practices in separate documents.




Figure 1: eduCourse data model

A UML static structure diagram [3] graphically represents the eduCourse data model (figure 1). A narrative description of the depicted object classes, their leading attributes, and their associations is given in section 2. To avoid confusion with the subject matter under discussion, these are referred to in this document as "object classes" rather than using the proper UML terminology of "classes".

Several attribute value types in the tables in section 2 below are marked "(IMS)". These are defined in the IMS Common Data Definitions Information Model [1].

2. Description of object classes, attributes, and associations

2.1. Course

The *course* objectclass models an abstract course, for example, one that appears in a catalog of courses. *Course* instances are not temporal objects (although the catalog of which they are a part might be).

The "crosslisted as" association enables a course instance to be associated with one or more other course instances for the purpose of expressing a crosslisting relationship among them. The target of a crosslisted as association is crosslisted as each of the sources of the association. Each source is considered to be a presentation of the target. The relationship need not be symmetric. A course instance which is a source for a crosslisted as association may also be a source for additional crosslisted as associations, i.e., one course can appear as a crosslisted presentation of any number of other courses. Not every course instance need be the target of a crosslisted as association.

2.2. Offering

A temporal instance of a *course* is represented as an *offering*. For example, Physics 12100 as offered during the 2004 Autumn Quarter is an *offering* instance.

The "occurs as an" association allows each offering instance to be the instantiation of one or more course instances. This facilitates a temporally constrained form of crosslisting. Each offering instance must be a source for at least one occurs as an association.

The "crosslisted as" association enables an offering object to be associated with one or more other offering objects for the purpose of expressing a crosslisting relationship among them. The target of a crosslisted as association is crosslisted as each of the sources of the association. Each source is considered to be a presentation of the target. The relationship need not be symmetric. An offering instance which is a source for a crosslisted as association may also be a source for additional crosslisted as associations, i.e., one course offering can appear as a crosslisted presentation of any number of other course offerings. Not every offering instance need be the target of a crosslisted as association.

2.3. Section

Multiple instances of a course offering may be required, either to scale the offering to meet course enrollment levels, or to reflect and manage different types of collocated activities necessary for the course. These are the *sections* of an *offering*. For example, students might separately register for lab, lecture, and recitation sections of a course.

The "composed of" association enables one offering to be composed of multiple sections, and also enables each section to be an element of one or more offerings. The latter capability is the fourth way that this data model supports a form of crosslisting – in this case, one in which only certain sections of a course offering serve a crosslisted function

(perhaps because not all instructors of *sections* of one *offering* hold a credential necessary to meet a requirement of the crosslisted *course*). Each *section* instance must be a source for at least one *occurs as an* association.

The "subsection of" association enables a section instance to contain any number of other section instances. This enables the eduCourse data model to express components of sections, for example, to group members at a more granular level than the section that instantiates a course offering, or to represent changes in roleType persons may have with a section over time. This version of the model does not incorporate any notion of content, but if it did, subsections could also be used to delineate the parts of a section by their content. A section instance that is a source for a subsection of association is exclusively "owned" by its target section instance – it may not be a source for any other subsection of association nor any composed of associations.

2.4. Member

The *member* objectclass is similar to the *Role* objectclass in the IMS Membership Management Services Information Model [2]. It represents a person connected with a *section* in one of several capacities (such as instructor, learner, teaching assistant, etc.). Attributes of the *member* objectclass that are named the same as IMS *Role* objectclass attributes have the same meaning as in the IMS specification.

Several IMS *Role* attributes are absent from this list. Of particular note is "timeFrame", which in this model is located with the *offering* objectclass. *Members* inherit a timeFrame from the *offering* to which they are associated either directly or indirectly via a *section* object. This model posits a persisted "personID" as opposed to the "userid" used in the IMS *Role* object to avoid the requirement that this identifier be meaningful to learning management applications.

The "having" association connects a member instance with the section or offering instance of which it is a member. Each member instance can be associated with at most one section instance and with at most one offering instance. Both types of association are permitted, enabling memberships to be rolled-up to the offering level or to be expressed only at the offering level in contexts in which that is appropriate. Each member instance must be associated with at least one offering instance or at least one section instance.

3. Bindings of the eduCourse data model

The term "eduCourse" will be used as a prefix or component of names of course-related schematic artifacts like attributes of person or course-oriented schema and names of XML schema or LDAP object lasses the MACE-

CourseID working group may decide to create, and as a qualifier for names of related UML packages, WSDL interfaces, or the like. Items named with or qualified by "eduCourse" should have a corresponding appearance in the evolving eduCourse data model (figure 1). Example uses:

"eduCourseOffering" - the name of an attribute (defined below).

"eduCourse offering" - qualifies that the "offering" refers to an instance of the *offering* objectclass in the eduCourse data model.

In this section are gathered the initial bindings of elements of the eduCourse data model.

3.1. eduCourseOffering

This is an attribute whose values are identifiers of eduCourse offering or section objects. Values are URIs.

When eduCourseOffering appears as an attribute of a person object, it is multivalued and represents a set of eduCourse offerings or sections associated with eduCourse member objects in which the person is identified by the personID attribute of the eduCourse member objects.

The MACE CourseID working group may recommend particular means of mapping a local system of eduCourse offering or section identifiers into a corresponding system of URIs. Example values:

3.2. eduCourseMember

This is an attribute whose values represent the roleTypes of eduCourse member objects associated with eduCourse offering or section objects. The value syntax is <role>@<eduCourseOffering value>, where <role> is either the value of the roleType attribute of an eduCourse member object that is associated with either an eduCourse offering or an eduCourse section object identified by <eduCourseOffering value>, or <role> is a URI.

When eduCourseMember appears as an attribute of a person object, it is multivalued and represents a set of associations between eduCourse offerings or sections and eduCourse member objects in which the person is identified by the personID.

Example values:

eduCourseMember: Learner@urn:mace:uchicago.edu:classes:autumn2004:phys12100.003 eduCourseMember: Instructor@http://wisc.edu/course/offering/2004fall/physics1101

5.4. Individual submission version 03

 - o Replaced the Session class with the "timeFrame" attribute of the offering class.
 - Tightened up the multiplicities, end adornments, and names of all associations to better reflect UML practice.
 They used to be more representative of relationships between tables in an RDBMS, which is an incorrect metaphor in the UML static structure context.
 - Tightened up attributes for each class to (1) declare their types, (2) omit ones named "..." that used to signal the fact that the working group hasn't yet attempted to fully schematize these objects (this is now acknowledged in the text), and (3) adopt as much of the IMS stuff as seems reasonable given the differences between our task and the circumstances that IMS is governing.

5.5. Individual submission version 02

This was a .gif-only version, "objStructure-v2.gif", the first attempt to express desired object structure using a UML static structure diagram.
