Working Group to develop concrete implementation guidance for NIH requirements

- o Tom will coordinate a CTAB sponsored working group to look at guidance for InCommon members guidance on NIH call to action
- Could include InCommon members and NIH people
- Need to develop the guidance and get it to InCommon participants
- CTAB will need to establish clear expectations around timing for the proposed working group around NIH expectations
- ChrisW: makes sense for CTAB to form a working group and move forward
- There's a strong incentive for R&E to figure out what needs to be done to meet the NIH requirements.
- What kind of processes can they leverage to achieve assurance level needed, around MFA for example?
- TomB has been convening a small group already, including ScottC
- Input to REFEDs is important
- o Alignment with NIST identity proofing guidance is also important
